1. The application for leave to appeal is set down for hearing on Thursday 14 May 2009 at 10h00.
  2. The record of the proceedings must include the record before the High Court, the judgments of the High Court, as well as the papers filed in the application before this Court.
  3. The record, properly paginated and indexed, must be lodged by Friday 3 April 2009.
  4. It is noted that all four respondents have lodged notices of intention to abide the decision of this Court. Nonetheless given that the issue before the Court concerns

the constitutionality of the KwaZulu-Natal Elimination and Prevention of Re-emergence of Slums Act, 6 of 2007, the respondents, whether jointly or individually, are requested to lodge written argument and to brief counsel to appear at the hearing in accordance with paragraph 5 of these directions. It would be of assistance to the Court if the views of both national government and the province of KwaZulu-Natal in relation to the legislation in issue could be placed before the Court.

5. Written argument, which shall include argument on the merits of the appeal should leave to appeal be granted, must be filed on behalf of:

- a. The applicants, by Tuesday 14 April 2009;
- b. The respondents, by Wednesday 29 April 2009.
